#### MAI RESPONSABILI

In 2017 we developed and tested a tool for assessing the quality of public services. The tool measures: information accessibility, bureaucratic requirements, the comfort of the waiting space, as well as the clogs and the efficiency of the institution. The evaluation questionnaire is hosted on the www.mairesponsabili.ro platform.

Mai responsabili aims to turn the assessment of the public institutions into a practice and to provide customized recommendations for each of the specific problems identified by the citizens.



# RECOMMENDATIONS FOR LOCAL OPEN GOVERNANCE

Center for Public Innovation, along with Smart City Association, has created a guide for local authorities. The guide recommends specific activities that help institutions become accountable, increase their transparency and involve citizens in the decision-making process.

The document also summarizes the steps and the documents that the local authorities must follow in order to implement the open government principles.





#### OPEN EDUCATIONAL RESOURCES

2017 was an important year for increasing access to open educational resources. The Ministry of Education embraced some of the recommendations that we have made together with members of the Coalition for Open Educational Resources, initiating the development of virtual school libraries that would host open educational resources produced by teachers, at the level of each county school inspectorate.

The Center for Public Innovation also proposed improvements to the draft Manual Law, highlighting the need for a technically and legally open format that would allow the reuse of the content of the textbooks that will be paid for by the Ministry of Education.



## OPEN EDUCATION ROMANIA NATIONAL CONFERENCE

In 2017 we organized the fourth national conference dedicated to open education. The conference topics in 2017 were copyright reform at European level and regional policies in the field of open education. The conference had participants from Poland, Slovakia, Bulgaria and Slovenia.

#### NIEM

2017 was the year of the first assessment of the national integration systems of the beneficiaries of protection under the NIEM-National Integration Evaluation Mechanism; Measuring and improving the integration of beneficiaries of international protection project.

The assessment consisted in analyzing over 30 national strategies, laws, ordinances, regulations and orders that directly or indirectly regulate migration and asylum; over 20 national and international reports on migration and asylum; as well as interviews with practitioners in the field of migration and asylum and dozens of requests for public information sent to institutions that hold responsibilities in the field of asylum, migration and integration.

In 2017 we founded, together with ten other nongovernmental organizations, the Coalition for Migrant and Refugee Rights.

### EQUAL RIGHTS

The Center for Public Innovation contributed in 2017, together with the members of the Coalition for Migrants' and Refugees Rights, to the amendment of Art. 9 of the Romanian Citizenship Law no. 21/1991, which regulates the right for a distinct certificate of citizenship to minor applicants, facilitating their access to all citizens' rights.

In 2017, together with 12 organizations and citizens, we initiated the RESPECT Platform for Rights and Freedoms, which opposes the narrowing of the family definition through the Constitution.
